# BAAC Annual Conference "Audiovisual Heritage and People: Connecting, Curating, Sharing", Vilnius, Lithuania. 2-3 November, 2016

The conference was organised jointly with partners from Lithuanian Central State Archive and Lithuanian Archivists' Association at the Arts Printing House in the centre of Vilnius. 42 registered participants from 11 countries took part in the conference; countries with most registered participants were Estonia with 14, and Latvia with 10 participants. This year's conference was also closely related to the Europeana Sounds project, which held its second international conference, "Unlocking Sound Collections", on the following day, November 4<sup>th</sup> at the Vilnius University. There were 18 presentations covering the topics from the preservation of sound collections to copyright issues.

# BAAC Photo Conservation Workshop, hosted by the Lithuanian Central State Archive. 20-21 June, 2016.

Organised by the Baltic Audiovisual Archival Council (BAAC), together with the Archivists' Association and Lithuanian Central State Archive. Workshop was led by well-known specialist Professor Bertrand Lavédrine from France. The workshop was partially financed by the Lithuanian Culture Council. The main goals of the workshop were to introduce specialists from memory institutions to actual and practical decisions and practices concerning photographic handling, preservation and access; to contribute to the safeguarding of Lithuanian photographic heritage; to strengthen relations among the international photography specialist community, while making it possible to share experiences. According to the workshop's organizers, all tasks of the workshop were successfully fulfilled.15 professionals from Lithuania, Estonia and Latvia took part of the workshop.
